

## Type 2 Industrial Facilities Installation

Procedure Without Prior Inspection



# **1** Facilities Covered in Type2

Type 2 industrial establishments are not included in type 1, but they are covered by at least one of the following legal regimes:

- European Greenhouse Gas Emissions Trading Scheme (CELE);
- Waste management operation (OGR) that dismisses prior inspection.

Are excluded from this typology establishments identified in part 2-A of Annex I of SIR, even if located in entitled buildings for commerce or services, provided that recovery operations of non-hazardous waste are carried out.

### **Installation and Operation**

#### **Preparatory elements**

- Electronic form (available at Balcão do Empreendedor);
- Descriptive Memory;
- Designed parts;
- Project of electric or thermal energy production or evidence of prior approval;
- Evidence of prior favorable information about urban operation or architectural design approval issued by City Hall, or declaration of option by the deferral of its delivery;
- Request for authorization of installation or operation of pressure equipment request, when applicable;
- Greenhouse gas emissions title request, if applicable;
- Waste management operations licensing request, when applicable;
- Information on the implementation of the environmental legal systems covered.

#### How to submit the request

#### 1. Through the online channel:

• Filling the "Framework form"

Free Access, without requiring authentication, where it is requested a set of answers that will allow, at the end, to classify the industrial facility, identify the applicable procedure, the Coordinator Entity (CE), the environmental regimes applicable and, when available, the rate value.

At the end of the filling, and if you intend to proceed with the application submission, the transition to the detailed form requires an authentication that will allow access to your confidential area, where it will be kept until their submission request (which ill only be allowed after the complete filling out the form and attach the required documents).

• Filling the "Detailed form"

Organized by sections aimed the characterization of the EI and generated based on the framework form. Like in the framework form, the given answers determine the questions raised in the course of filling out the application.

The last section (P-attachments), is suitable to attach all necessary documents to the statement of claim. This section is presented by items according to the supporting elements contained in the Portaria referred above.

#### 2. Digital Assisted Service

• Can be provided digital assisted service at the "Balcão do Empreendedor" by the presential attending services of the coordinating entities;

• The fees charged for the order have an additional value when the digital assisted service is requested.

#### **Required fees**

• Determined by Portaria No. 280/2015, of September 15th and Portaria No. 332-B/2015, October 5th (fees related to the environmental regimes);

#### Deadline for decision about the request for installation

#### Enabling document for the exercise of the activity

• Installation and Operation Title

## **Beginng of Operation**

The exploitation of the establishment can start as soon as the following elements are issued:

- Operation and installation title;
- Authorization to use title (permit of use license);
- Non-contractual liability insurance contract (see article 4 of SIR).

The date of the beginning of the exploitation should be communicated to the Coordinator Entity, at least 5 days before (art. 32 of SIR).
